

# Policy Requirements: Teaching Sex Education Topics

## Requirement:

Law and policy training is mandatory for all new or newly assigned educators of sex education topics and must be renewed every three years. All health and certain CTE, science, and psychology educators must complete this training. CTE, science, and psychology teachers should complete this training if they teach eligible courses like Child Development, Health Science, Medical Anatomy, Human Development, Genetics, or any course with instruction on sex education as defined in [Utah Code 53G-10-403](#). The USBE offers a free online training which can be found on the [health education webpage](#).

## Topics Requiring Training

If the course includes instruction on of the defined topics below, the educator must complete law and policy training, parents must be sent the approved Parental Consent Form, the instructional materials, guest speakers, and media need to be reviewed by the LEA Curriculum Materials Review Committee, and all materials, guest speakers, and media used are approved and adopted by the local board in an open and public meeting ([53G-10-402](#) and [R277-474-5\(4\)\(b\)](#))

(i) "Sex education instruction" means any course material, unit, class, lesson, activity, or presentation that, as the focus of the discussion, provides instruction or information to a student about:

- sexual abstinence;
- human sexuality;
- human reproduction;
- reproductive anatomy;
- physiology;
- pregnancy;
- marriage;
- childbirth;
- parenthood;
- contraception;
- HIV/AIDS;
- sexually transmitted diseases; or
- refusal skills, as defined in Section [53G-10-402](#).

Law and policy training is required every three years for all educators giving instruction in any topic included in the definition of sex education per 53G-10-403.
